

## **September 4, 2024, POST Council Meeting:**

### **Officer A:**

Officer A was investigated for driving under the influence of alcohol of drugs. POST Council suspended Officer A's POST certifications for one-and-a-half-years.

### **Officer B:**

Officer B was investigated for driving under the influence of alcohol, open container, and carrying a dangerous weapon while under the influence of alcohol. POST Council suspended Officer B's POST certifications for two years.

### **Officer C:**

Officer C was investigated for negligently operating a vehicle resulting in injury. POST Council suspended Officer C's POST certifications for three years.

### **Officer D:**

Officer D was investigated for sexual conduct on duty and Garrity violation. POST Council revoked Officer D's POST certifications.

### **Officer E:**

Officer E was investigated for unlawful detention and stalking. POST Council revoked Officer E's POST certifications.

### **Officer F:**

Officer F was investigated for sexual conduct on duty. POST Council suspended Officer F's POST certifications for one-and-a-half-years.

### **Officer G:**

Officer G was investigated for unlawful sexual conduct with a 16 or 17 year old. POST Council revoked Officer G's POST certifications.

### **Officer H:**

Officer H was investigated for falsification of a government record. POST Council suspended Officer H's POST certifications for one-and-a-half-years.

### **Officer I:**

Officer I was investigated for driving under the influence of alcohol. POST Council suspended Officer I's POST certifications for two years.

**Officer J:**

Officer J was investigated for distribution of pornography. POST Council suspended Officer J's POST certifications for four years.

**Officer K:**

Officer K was investigated for possession or use of a controlled substance (marijuana). POST Council suspended officer K's POST certifications for one year.

**Officer L:**

Officer L was investigated for Garrity violation and sexual conduct on duty. POST Council revoked Officer L's POST certifications.

**Officer M:**

Officer M was investigated for custodial sexual relations. POST Council suspended Officer M's POST certifications for three years.

**Officer N:**

Officer N was investigated for electronic communication harassment. POST Council suspended Officer N's POST certifications for one-and-a-half-years.

**Officer O:**

Officer O was investigated for unlawful sexual conduct with a 16 or 17 year old. POST Council revoked Officer O's POST certifications.

**Officer P:**

Officer P was investigated for driving under the influence of alcohol. POST Council suspended Officer P's POST certifications for two years.

**Officer Q:**

Officer Q was investigated for assault and dishonesty in violation of department policy. POST Council suspended Officer Q's POST certifications for two years.

**Officer R:**

Officer R was investigated for driving under the influence of alcohol, carrying a dangerous weapon while under the influence of alcohol, and dishonest in violation of department policy. POST Council suspended Officer R's POST certifications for two years.

**Officer S:**

Officer S was investigated for criminal trespass. POST Council issued a letter of caution.
