Officer A:

Officer A was investigated for child abuse. POST Council suspended Officer A's POST certifications for three months.

Officer B:

Officer B was investigated for sexual conduct on duty. POST Council suspended Officer B's POST certifications for three-and-a-half years.

Officer C:

Officer C was investigated for driving under the influence of alcohol. POST Council suspended Officer C's POST certifications for one-and-a-half years.

Officer D:

Officer D was investigated for unlawful use of cannabis. POST Council suspended Officer D's POST certifications for one year.

Officer E:

Officer E was investigated for falsification of a government record. POST Council suspended Officer E's POST certifications for two-and-a-half years.

Officer F:

Officer F was investigated for misuse of public money and unlawful use of a financial transaction card. POST Council revoke Officer F's POST certification.

Officer G:

Officer G was investigated for sexual conduct on duty. POST Council suspended Officer G's POST certifications for three-and-a-half years.

Officer H:

Officer H was investigated for sexual conduct on duty. POST Council suspended Officer H's POST certifications for two years.

Officer I:

Officer I was investigated for dishonesty in violation of department policy. POST Council suspended Officer I's POST certifications for six months.

Officer J:

Officer J was investigated for BCI violation, unlawful disclosure, stalking, and Garrity violation. POST Council revoked Officer J's POST certifications.

Officer K:

Officer K was investigated for intoxication. POST Council suspended Officer K's POST certifications for three months.

Officer L:

Officer L was investigated for sexual battery. POST Council suspended Officer L's POST certifications for three years.

Officer M:

Officer M was investigated for stalking and unable to possess a firearm. POST Council revoked Officer M's POST certifications.

Officer N:

Officer N was investigated for propelling bodily fluid and DV in the presence of a child. POST Council suspended Officer N's POST certifications for two-and-a-half years.

Officer O:

Officer O was investigated for possession of a controlled substance. POST Council suspended Officer O's POST certifications for one year.

Officer P:

Officer P was investigated for animal cruelty. POST Council suspended Officer P's POST certifications for six months.

Officer Q:

Officer Q was investigated for unfit for duty. POST Council suspended Officer Q's POST certifications indefinitely.

Officer R:

Officer R was investigated for having an active protective order/unable to possess a firearm. POST Council suspended Officer R's POST certifications until November 22, 2027.

Officer S:

Officer S was investigated for retail theft. POST Council suspended Officer S's POST certifications for one-and-a-half years.

Officer T:

Officer T was investigated for possession of a controlled substance/unable to possess a firearm. POST Council suspended Officer T's POST certifications until March 27, 2026.

Officer U:

Officer U was investigated for electronic communications harassment. POST Council suspended Officer U's POST certifications for one year.

Officer V:

Officer V was investigated for assault. POST Council issued a letter of caution.

Officer W:

Officer W was investigated for unfit for duty. POST Council suspended Officer W's POST certifications indefinitely.

Officer X:

Officer X was investigated for driving under the influence of alcohol. POST Council suspended Officer X's POST certifications for one year.

Officer Y was investigated for BCI violation. POST Council suspended Officer Y's POST certifications for one year.
